AUTHORIZATION TO REPLACE MULTIFUNCTION DEVICES

Mr. Weisberg moved, seconded by Mr. Gorson that the Board of Education approve the resolution declaring the Intention to issue \$17,000,000.00 Working Cash Fund Bonds for the purpose of increasing the Working Cash Fund of the District and directing that notice of such intention be published in the manner provided by law. On roll call, Mr. Weisberg, Mr. Gorson, Mrs. Moons, Mrs. Neault, Mrs. Shang, and Mr. Frost voted aye. The motion carried unanimously.

RESOLUTION **DECLARING** the **INTENTION to ISSUE** \$17,000,000.00 **WORKING CASH FUND BONDS for the PURPOSE of INCREASING** the WORKING CASH FUND of the DISTRICT and DIRECTING THAT NOTICE of SUCH INTENTION be **PUBLISHED** in the MANNER PROVIDED by LAW
